- ___ (5) Commission of a criminal act on school property or during school-affiliated activities;
- ___ (6) Misconduct that would merit suspension or expulsion under school policy;
- ___ (7) Habitual truancy (all procedures, including the implementation of a Truancy Elimination Plan (TEP) must have been implemented and followed PRIOR to placing habitually truant students in AEDY programs.)
